Freshet Water Management and Mitigation Strategy Approval

The Mackenzie Valley Land and Water Board (the Board) met on March 1, 2012 to review the Freshet Water Management and Mitigation Strategy (the Strategy) in accordance with Part E Item 8 of the current water licence (MV2001L2-0002).

The Board acknowledges the short timelines that have been provided to reviewers to comment on the Strategy, but understands the importance of conducting mitigative work before the 2012 freshet. In order that the immediate risks associated with the spill plume are resolved, the Board approves the Freshet Water Management and Mitigation Strategy as submitted.

The Board also acknowledges the commitments made by De Beers in their responses to reviewer's comments submitted to the Board on February 27, 2012 and requires De Beers Canada (De Beers) to adhere to these commitments. These commitments include:

- IL6 will be used as a water management sump, then the water level in IL6 should be maintained below 444.0 meters above sea level, which is the maximum design water level for Perimeter Sump #4 (SP4) and #5 (SP5);
- one monitoring station between the shoreline and IL6 should be established to detect any possible seepage from IL6 to Snap Lake; and
- In addition to the water level thresholds, a defined water alert threshold should be set up for the amount of mine water originating from the underground workings, to trigger the use of underground workings as temporary water storage.

DeBeers is reminded that future submissions for relevant management plans should be updated to reflect the changes associated with the IL6 Ditch Design
